Learning Outcome	By the end of the course, trainees will be able to: (a) understand the supervisory skills required to direct and monitor a team of cash-in-transit crew in carrying out duties of safe escort and carrying of cash or valuables from one or more locations to another and maintain performance standard (b) understand the communication skills required to maintain effective relationships with clients and team members, and write detailed report (c) operate and monitor the use of communication and security equipment (d) *operate and handle of firearms according to safety instruction (e) detect irregularities and identify persons involved in suspicious activities and take appropriate actions (f) identify property equipment damages/defects and to take appropriate action for rectification (g) understand the essential laws and regulations relating to security services (h) understand the fire safety, first aid and risk management
