## 前言

1.01 政府於 2020 年 7 月 8 日發表了《有關引入窺淫、私密窺視、未經同意下拍攝私密處及相關罪行的建議的諮詢文件》(“《諮詢文件》”),邀請公眾人士就《諮詢文件》所述的立法建議發表意見。在諮詢期間,公眾人士可透過以下渠道遞交意見:

- (a) 郵寄至保安局;
- (b) 傳真(2501 4281);或
- (c) 電郵(consultation@sb.gov.hk)。

## 公眾書面意見

1.02 公眾諮詢至 2020 年 10 月 7 日結束。在公眾諮詢期,保安局透過郵寄、傳真及電郵方式共接獲 201 份意見書,當中包括團體、學者及個別公眾人士的意見書。除當事人要求將其意見書保密外,所有意見書現載列於本附錄內,並盡量按我們收到意見書的日期順序排列。我們亦已按要求以不具名方式表達意見的人士的意願,把相關意見的署名刪除。

## 個人資料的處理

1.03 為了保障發件人的資料私隱,我們在編印意見書時已刪除發件人的電郵地址。若發件人有提供其他的個人資料(例如身分證號碼、電話號碼、傳真號碼、地址等),亦都已被刪除。

1.04 我們以同一方法處理以郵寄或傳真方式遞交的意見書,把發件人的個人資料(包括身分證號碼、簽名、回郵地址及傳真號碼等)刪除。

- 1.05 在無法與發件人確認他們是否同意在刊載他們的意見的同時把身分公開的情況下，我們會刪除他們在意見書上的署名。

### 諮詢期完結後收到的意見書

- 1.06 我們在諮詢期完結後共收到 1 份意見書。就該意見書而言，我們採取了與上文一樣的處理方法，並同時把它納入本附錄以供參考。
- 1.07 在編印過程中，或有遺漏缺失之處。如有需要，我們將於日後作出適當更正。

## **Foreword**

- 1.01 The Government published the consultation paper on the “Proposed Introduction of Offences of Voyeurism, Intimate Prying, Non-consensual Photography of Intimate Parts, and Related Offences” on 8 July 2020 to solicit public views on the legislative proposals therein. During the public consultation, members of the public were invited to submit their views through the following channels:
- (a) by mail to the Security Bureau (“SB”);
  - (b) by facsimile (2501 4281); or
  - (c) by email (consultation@sb.gov.hk).

## **Written submissions from the public**

- 1.02 The public consultation ended on 7 October 2020. During the public consultation, SB received a total of 201 written submissions via mail, facsimile and email, including written submissions from organisations, academics and individuals. Except for submissions for which the senders have requested that their views be kept confidential, all the submissions are published in this Appendix and arranged, where possible, according to the date of receipt. Besides, we have removed the names on the submissions for which the senders have requested anonymity.

## **Handling of personal data**

- 1.03 In order to protect the privacy of the senders, we have removed the senders’ email addresses when publishing email submissions. If the senders have provided other personal data, such as identity card numbers, telephone numbers, facsimile numbers, residential addresses, etc., such data have also been removed.
- 1.04 We have adopted the same approach in handling submissions which were submitted by mail or facsimile. The personal data of the senders, including identity card numbers, signatures, return addresses and facsimile numbers, have been removed.
- 1.05 Under the circumstances that we were unable to ascertain

whether the senders wish to disclose their identity when their views are published, we have removed their names from their submissions as well.

### **Submissions received after the end of the consultation period**

- 1.06 We have received 1 submission after the end of the consultation period. We have adopted the same approach in processing this submission as mentioned above, and have also included it in this Appendix for reference.
- 1.07 There may be errors and omissions in the compilation of this Appendix. We will make the appropriate amendments in the future if necessary.
